This Invitation for Bids follows the General Procurement Notice for this project that appeared in *Development Business* No. IDB -P549572-08/20 of August 25, 2020.

The Government of the Republic of Trinidad and Tobago has received a loan from the Inter-American Development Bank (IDB) toward the cost of the Urban Upgrading and Revitalization Programme, and it intends to apply part of the proceeds of this loan to payments under the contract for Refurbishment of the Eastside Plaza – P2304.

The National Insurance Property Development Company Limited (NIPDEC) now invites sealed bids from eligible bidders for the Refurbishment of Eastside Plaza. Eastside Plaza is located in the City of Port of Spain, on the site of the former Eastern Market. The mall spans from Charlotte Street on its western entrance to George Street on the eastern entrance.

The works involve demolition, building works, roof works, glazing works, supply, and installation of – finishes, lifts and escalators, sanitary appliances and fittings, furniture and equipment, HVAC equipment, water storage and potable water pumping system, fire suppression system and electrical infrastructure. The delivery/construction period is 520 calendar days following the Commencement Date.

This Request for Bids (RFB) will be conducted through the international competitive bidding procedures specified in the Inter-American Development Bank's *Policies for The Procurement of Works and Goods Financed by The Inter-American Development Bank* and is open to bidders from all countries as defined in the guidelines.
