Only firms purchasing RFP packages shall be permitted to submit a Proposal. Any Proposal submitted by a Firm which has not purchased an RFP package shall be rejected as invalid.

Please note that:

- (i) The works as detailed would be evaluated as a batch. A firm can only win two (2) of the five (5) Tenders, and once that firm is recommended for the award of contract that firm will no longer be eligible for any other award of contract within that batch.
- (ii) Tenderers shall bear all costs associated with the preparation and submission of the Tender, including the Tender Fee, both of which are not reimbursable.
- (iii) Site Visits required after dates published are allowed, however, no MOWT Drainage representative will be present on site.
- (iv) NIPDEC is not bound to accept any of the Tenders submitted.
- (v) Only firms that are pre-qualified with the Office of the Procurement Regulation (OPR) will be eligible for award.
